2020 Invoicing schedule

The annual fee corresponds to two service options and is a one-time payment each year.

The annual fee is due, whenever the new registrar is accredited.

A Registrar may choose between the “Option 1” annual fee or the “Option 2” annual fee.

A change of Options can be made only at the time the contract is renewed, by sending a message to Afnic prior to December 31 of the current year, to take effect on the 1st of the following January.

A description of services included in each of the Options can be viewed at Afnic’s Web site.

* Domain names can be registered and renewed for a period of 1 to 10 years. Creations and renewals for more than one year are billed and payable at once, for an amount equal to the price of the chosen option multiplied by the number of years required for registration.

** Charged the month following the anniversary month of the last paid administrative action.



Specific conditions:

- 1) In application of Article 28, “Assignment of the Contract”, the total transfer of a portfolio of domain names is executed upon estimate of Afnic commercial department.
- 2) Expenses incurred by Afnic for bounced cheques shall result in the imposition of a penalty in the amount of 10 €, excluding tax, for each bounced cheque, to be deposited via electronic funds transfer or by bank card, beginning with the 2nd bounced cheque, independently of the application of Article 10 in the contract regarding imposition of a standard penalty in case of default.
- 3) In the case of grace periods related to creation operations, the amount of the monthly credit per registrar shall not exceed the amount corresponding to:
 - the creation of 50 domain names, or
 - 10% of the number of net creation for the month.Afnic will retain the higher of the two values as the amount of the credit.
