Any untruthful statement that is liable to be detrimental to the association is covered by Article 441-1 of the French Criminal Code of Law.

- The trustee, his or her spouse and/or children are in direct or indirect link with a competitor of Afnic, or sell products competing with those sold by Afnic. This does not apply to the retailing of domain names by registrars accredited by Afnic.
- The trustee, his or her spouse and/or children have contractual business relations (unless the contract is a standard Afnic contract).
- The trustee, his or her spouse and/or children have a relationship or link with a company whose relationship with Afnic is that of a customer (excluding registries and registrars) or a supplier.
- The trustee, his or her spouse and/or children directly, or through a corporation, has a role as a specifier in a call for tenders launched by Afnic, or in which Afnic takes part.
- The trustee, his or her spouse and/or children have a role, directly or through a consultancy company with a competitor, customer or supplier.
- The trustee, his or her spouse and/or children have taken legal action against Afnic.
